- A. Mayor's Representative: Dave Mauger
  - 1. Win Cody had his last Township Committee meeting.
  - 2. There was concern by some community members about the location of the Christmas tree and the new menorah since it blocks the Veteran's Memorial. It will stay in its current location this year, but its location will be considered for next year.
- B. Chief School Administrator: Michael Ferrante
  - 1. The Princeton High School Principal came to discuss with parents the transition to the High School for eighth graders.
  - 2. Cranbury School test scores, especially for Middle School, are very strong, among similar schools.
- C. Friends of the Cranbury Public Library Representative: James Fahey, Friends' Vice President
  - 1. The program re-scheduled on December 27 will showcase students who have graduated from Princeton High School about their journey as Cranbury School Students
  - 2. The Friends are aggressively searching for new Board Members, especially for Publicity.
  - 3. The Friends are considering funding a quarterly mailing that would include Library and Friends' events and programs.
  - 4. The Friends just updated their Bylaws.
- D. Cranbury Public Library Foundation: Patricia Thomsson
  - 1. Some significant donations have come in.
  - 2. Some concerns about the building have been raised and sent back to the Cranbury Public Library Board Facilities Committee.
  - 3. Monday, January 9 will be the Annual Meeting, reconfirming officers.
  - 4. In May, the Foundation will take a look at how we are doing.
  - 5. Patty will start to look at Grants. We do not have 100% participation from our two Boards, which could hurt us in the grant process.

- A. Personnel Committee: Kim Borden via Kirstie Venanzi
  - 1. Kirstie and Kim met with Marilynn to share her review. Marilynn signed her contract for 2012.

  - 1. Our Township appropriation for 2012 will be decreased by 3.2%.
  - 2. The cost of health insurance has skyrocketed.
